Quarantine helps prevent spread of disease that can occur before a person knows they are sick or if they are infected with the virus without feeling symptoms. People in quarantine should stay home, separate themselves from others, monitor their health, and follow directions from their state or local health department.

Quarantine – Quarantine refers to the practice of separating individuals who have had close contact with someone with COVID-19 to determine whether they develop symptoms or test positive for the disease. Quarantine reduces the risk of transmission if an individual is later found to have COVID-19.

Health Screening: Thermal screening shall be done for both international and domestic passengers. For international travellers: Passengers travelling should also give an undertaking on the portal that they would undergo mandatory quarantine for 14 days i.e., 7 days paid quarantine at their own cost followed by 7 days isolation at home with self-monitoring of health.

They are required to have a negative COVID 19 RT-PCR test result taken within seven (7) days of their flight.
